
The restaurant is open between 7:30 am and 9:00 am for breakfast, 11:45 am and 1:45 pm for lunch and 7:30 pm and 9:30 pm for dinner, weekdays and week end. Wearing a mask is mandatory to enter the restaurant and when preparing your meal tray. This mask must be discarded after the payment of the meal, in the bin provided for this purpose.

- · Limit your time at the restaurant
- Respect the distance rules, and the posted instructions
- Wash your hands before and after meals. Hydroalcoholic gel is available at checkout
- Payment only with the SOLEIL badge or by bank card
- Tables and chairs are cleaned regularly by the service provider

The Cafeteria, coffee machines and vending machines are back into service. Refer to the operating instructions displayed on the devices.



If you have the following symptoms



- You are on the SOLEIL site: imperatively contact the Security PC (Red phone or 18 from any SOLEIL extension)
- You are at home: do not come to the SOLEIL site, avoid contact with those around you, call your doctor or 15 if the symptoms worsen, and inform your contact at SOLEIL and your employer.
- You have come to the SOLEIL site during the last 7 days, inform your contact at SOLEIL

CoViD-19 Instruction for Synchrotron SOLEIL Users

You are entering the Synchrotron SOLEIL site

Use the following rules to protect your health and that of others

These instructions may change based on government instructions

Stay alert and vigilant

This document contains a summary of the instructions that you must follow throughout your stay at SOLEIL. A lot of other information is given on the site by way of display (traffic direction in certain zones, protocols for using equipment, maximum number of people authorized in a room, etc.). **Pay also attention to these instructions and respect them.** If in doubt, refer to your local contact at SOLEIL.

To enter the site, you must:

- Be declared on a list of participants validated by the Users' Office
- Have previously completed the Safety Training taking into account the specific measures related to the CoViD-19 epidemic
- Present yourself at the reception respecting the direction of traffic and the rules of distance (at least 1m)

Throughout the day, you must scrupulously apply the protective measures





Wash your hands very often with soap and water

Cough or sneeze into your elbow or a disposable tissue

eze Use a disposable or a tissue and throw it sue away

To prevent the spreading of the disease, stay more than 1 meter away from each other.

Avoid gatherings, limit your displacements and contact.



Avoid touching your eyes, nose, mouth.

When to wear a mask against the Covid-19?

Wearing a mask is complementary to protective measures.

It is compulsory to wear a mask in every confined space on site, in all buildings: halls, passageways, beamlines, workshops, meeting rooms, and any offices in which there is more than one person.

Only the mask provided by your employer is authorized on site.

Wearing a surgical mask is also mandatory in the company restaurant, when preparing your meal tray. Apart from the company restaurant, eating in the offices is tolerated, provided you are alone.

In confined spaces, taking off your mask is tolerated very briefly to hydrate.

Refer to the instructions for the use of masks, available on site.



Work organization

Please note that the specific risk associated with CoViD-19 must be taken into account in addition to the other risks existing at your workplace. The compatibility of the various preventive measures must be checked. **If in doubt, refer to your contact at SOLEIL.**

• Follow the instructions specific to each beamline, laboratory or workshop.

- Wear gloves only if recommended at your workplace (single use or household). Wash your hands after removing them. Wash gloves if they are reusable.
- For any intervention, limit the number of people to what is strictly necessary.
- Limit the sharing of objects as much as possible.
- In certain premises (control room, control hutches, etc.) where sharing of equipment (keyboards for example) is inevitable, specific equipment and a protocol for use will be available to you.
- Reduce contact, stagger breaks and be alert to lone worker situations that may result.



Cleaning and disinfection of premises and equipment, we are all players ...

Housekeeping teams clean and disinfect shared areas twice a day (door and window handles, elevator buttons, light switches, stair rails, sanitary facilities, control room)

- Clean and disinfect shared objects (telephone, table, keyboard, vehicle interior ...) before and after each use (resources available on site)
- Throw the waste in the containers provided for this purpose and, on the beamlines, following the instructions of your SOLEIL contact
- Ventilate the premises as much as possible.



When you are at the guest house, follow the instructions displayed:

- A **floor marking** is set up in **the reception hall** to help you respect the rule of physical distance
- A direction of circulation is set up in the common parts (corridors to the rooms)
- The two common relaxation areas are out of service

Only payments by bank transfer or credit card will be accepted (no cash or check).

In addition to scrupulous **cleaning** of the premises, **a period of 24 hours** will be observed before the re-rental of a room.
